



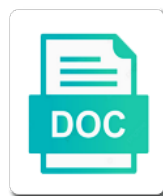
Notice Of Abandonment In Marine Insurance

Sometimes referred to as the "Notice of Abandonment" or "Notice of Relinquishment," this document is a formal statement by the insured party to the insurer, indicating that the insured party has decided to abandon the insured property to the insurer in exchange for the insurance proceeds. This document is typically required in the event of a total loss or a partial loss that is not covered by the policy.
